I expressly accept and assume all of the risks inherent in this activity or that may be caused by negligence. I agree to discontinue participation in the Club if I believe at any time that the conditions are unsafe or that I am no longer able to participate due to my physical or mental condition. I will be solely responsible for any and all medical and related bills that I may incur because of an injury or damage I may suffer or cause while participating in the Club, including those sustained on school premises and while I am traveling to and from such premises, regardless of the location or mode of transportation.		
I voluntarily release, forever discharge, and agree to indemnify and hold harmless the PHTH and its owners, instructors, employees, agents, volunteers, participants, and all other persons or entities acting for them ("Releasees"), from any and all claims, demand, loss, liability, damages, attorney fees, and any other costs which are in any connected with my participation in the Club, or my use of PHTH's equipment or facilities, including those arising from the negligence or omissions of the Releasees.		
This Agreement shall be governed and construed according to the laws of the state of Michigan without regard to its conflict of laws provisions.
